Part 1

General Regulations

§15-101. Definitions and Interpretation.

- 1. Words and phrases, when used in this chapter, shall have the meanings ascribed in the Vehicle Code, 75 P.S. §§101-9701 (1977), as hereafter amended, supplemented, modified or reenacted by the General Assembly of Pennsylvania, unless the context clearly indicates a different meaning.
 - LEGAL HOLIDAYS New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas.
- 2. In this chapter, the singular shall include the plural; the plural shall include the singular; and the masculine shall include the feminine.

§15-102. Manner of Adopting Permanent Traffic and Parking Regulations.

All traffic and parking regulations of a permanent nature shall be enacted as ordinances, as parts of ordinances, as amendments to ordinances, or as amendments to this chapter.

§15-103. Temporary and Emergency Regulations.

- 1. The Mayor shall have the following powers to regulate traffic and parking temporarily and in time of emergency:
 - A. In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations.
 - B. In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.
- 2. Such temporary and emergency regulations shall be enforced by the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or tractor in violation of any such regulations, or who shall move, remove, destroy, injure or deface any sign or marking erected, posted or made to give notice of any such regulation, shall, upon conviction thereof, be liable to the penalty set forth in the law or elsewhere in this Chapter 15 for a

violation of such nature, and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this chapter, to a fine of not more than \$25, together with costs of prosecution.

§15-104. Experimental Regulations.

Council may, from time to time, designate places upon and along the highways in the Borough of Beaver where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective just as they had been specified in this chapter. No person shall operate or park a vehicle or tractor in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who shall violate any provision of this section shall, upon conviction thereof, be liable to the penalty set forth in the law or elsewhere in this chapter for a violation of such nature, and in case of a violation for which no specific penalty is set forth in the law or elsewhere in this chapter, to a fine of not more than \$25, together with costs of prosecution; provided that the purpose of this section is to allow for the test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Borough relative to traffic and parking.

§15-105. Authority to Use Speed Check Devices.

- 1. The use of mechanical, electric or electronic devices, including but not limited to ESPTK 100, Vascar devices, Speed Check, or similar devices, within the Borough of Beaver to check or time excessive speeds is approved by the Town Council of the Borough of Beaver, provided that such device be of the type authorized by the Department of Revenue and calibrated and tested periodically for accuracy within the period, all as required by statute, and certified as to accuracy and testing as is required by law.
- 2. Operators of such equipment or device shall be required to be instructed and certified as to the use of such device, the certification to be by such stations or agents set up or authorized by the Department of Revenue, all as required by law.
- 3. Advance warning signs shall be erected upon the streets entering the Borough at or near the Borough line and on and along all State highways or upon other roadways or streets within the Borough of Beaver upon which such devices are to be used and operated. Such signs shall be at least 30 inches wide, 24 inches high, with a legend of black letters upon a white reflector announcing "Speed

Part 2

Traffic Regulations

§15-201. Speed Limits Established.

1. The following speed limits are hereby established:

Street	Between	Speed Limit
Third Street	Commerce Street and Sassafras Lane	35 mph
All borough streets except the portion of Third Street listed above	Entire extent	25 mph

2. Any person who shall operate a vehicle at a speed in excess of that established therefor, upon any highway or portion thereof as specified in this section, shall, upon conviction thereof, be sentenced to pay a fine of \$35 and, for exceeding a maximum speed limit by more than five miles per hour, shall pay an additional fine of \$2 for each mile per hour in excess of five miles per hour over the maximum speed limit.

§15-202. Traffic Signals at Certain Intersections.

1. At the following intersections, official traffic signals shall be erected (or are hereby ratified if heretofore erected), and traffic at such intersections shall be directed by such signals:

2. Any driver of a vehicle who shall disobey the directions of any traffic signal shall, upon conviction thereof, be sentenced to pay a fine of \$25 together with costs of prosecution.

§15-203. Right Turn on Red Signal Prohibited at Certain Intersection.

1. It shall be unlawful for the driver of any vehicle traveling on the first-named street at any of the following intersections, in the direction or directions hereby indicated in each case, to make a right turn when his or her vehicle is facing a steady red traffic signal:

§15-204. Stop Intersections.

1. The following intersections are hereby established as stop intersections, and official stop signs shall be erected (or are hereby ratified if heretofore erected) in such a position as to face traffic approaching the second-named street upon the first-named street, in the direction or directions hereby indicated. It shall be unlawful for all vehicles approaching any such intersection upon the first-named street, in the direction or directions hereby indicated, to not come to a full stop, within a reasonable distance, before entering any such intersection:

§15-205. Yield Intersections.

§15-206. Through Streets Established.

1. The following streets are hereby established as through streets, and the driver of every vehicle upon approaching any such street at any intersection thereof (except for intersections where there are now or shall hereafter be located official traffic control signals) shall come to a full stop, within a reasonable distance before entering any such through street:

 - B. Provided further that said weight limit shall not apply to any type of vehicle making deliveries to or picking up goods, wares or merchandise from property located upon any street upon which a weight limitation is imposed, nor shall said weight limit apply to operation of any vehicle where a special permit shall have been issued by the Chief of Police to operate such vehicle regardless of weight.
 - C. Provided further that the above limitation shall not apply to vehicles, trucks or truck-tractors hauling food, household goods, garbage or rubbish, building materials nor to public utility vehicles, fire-fighting equipment or to school or public transportation buses or vehicles.

Any person who violates this section is guilty of a summary offense and, upon conviction, shall be sentenced to pay a fine of \$75, plus \$75 for each 500 pounds, or part thereof, in excess of 3,000 pounds over the specified weight limit. In the event such fine is not applicable, any person who violates this section shall be sentenced to pay a fine of not less than \$300 nor more than \$600, plus all costs of prosecution, or, in default of payment, to undergo imprisonment for not less than 10 nor more than 30 days.

§15-211. Engine Brake Retarder Equipment.

- 1. Definition. As used in this Section, the term engine brake retarder equipment shall mean compression release engine braking systems used on gasoline-powered or diesel engines.
- 2. Purpose. The Council of the Borough of Beaver has determined that the use of engine brake retarder equipment creates excessive noise, and is otherwise detrimental to public health, safety and welfare, and is therefore declared a public nuisance.
- 3. Prohibition. The use of engine brake retarder equipment is hereby prohibited on Third Street (State Route 68) between the western boundary line of the Borough near Sassafras Lane and Wilson Avenue on the east.
- 4. Exception. This prohibition shall not apply to emergency vehicles while responding to an emergency, nor any vehicle in time of imminent danger or distress.
- 5. Signage. The Borough shall provide public notice of this prohibition by erecting and maintaining signage in accordance with applicable regulations of the Pennsylvania Department of Transportation.
- 6. Penalty. Any person who violates this Section, or who causes or permits such violation, shall upon conviction before a magisterial district judge be sentenced to pay a fine of not less than \$100 nor more than \$500 and costs of prosecution.

§15-301. Loading and Unloading.

The loading and unloading of goods, wares and merchandise is hereby restricted to such length of time as is absolutely necessary for the purpose of loading or unloading of such goods, wares and merchandise. For the purpose of enforcement of this section, such loading or unloading of any vehicle shall not be considered as parking; provided that, without having first obtained permission from the Chief of Police to do so, no person shall load or unload a vehicle from any place upon any street or alley in the Borough of Beaver where parking is prohibited; or shall allow a vehicle to remain, for loading or unloading, in any place upon any street or alley where parking is limited as to time, for longer than the time for which parking is permitted; or shall load or unload upon any street or alley in such a way that one lane for vehicular traffic shall not be kept open at all times. Where such permission is granted by the Chief of Police, he may, at his discretion, block off the portion of the street or alley affected by such loading or unloading.

Any person or persons who cause a vehicle to remain in a parking space after the prescribed time, for which coins or tokens have been deposited, has elapsed is hereby determined to be illegally parked; and each additional hour that such person or persons permit such vehicle to remain in an individual parking space after the prescribed time for parking has elapsed is hereby declared to be an additional violation. The fact that a vehicle is in an individual parking space when the time signal on the parking meter regulating said parking space shows that no parking is permitted, or that the time has expired, shall be deemed prima facie evidence of the unlawful parking of said vehicle by its operator and/or owner. The elapse of one hour from the time reported on the notice to the owner or operator of a motor vehicle, shall be deemed prima facie evidence of additional violations of the parking of said motor vehicle by the operator or owner.

It shall be unlawful and a violation of this part for any person to deface, tamper with, open or wilfully break, destroy or impair the usefulness of any parking meter, or parking meter stand or coin depository installed under the provisions of this part provided that nothing herein shall apply to the servicing or opening of parking meters by officers, employees and/or police officers of the Borough under the direction of the Mayor and/or the Borough Council.

§15-409. Penalties.

- 1. A person who violates §15-408 shall be sentenced to pay a fine of not less than \$300 nor more than \$600, plus all costs of prosecution, or, in default of payment, to undergo imprisonment for not less than 10 days nor more than 30 days.
- 2. A person who violates any other section of this Part shall be sentenced to pay a fine of not less than \$10 nor more than \$20, plus all costs of prosecution. [Ord. 782]

§15-410. Exceptions.

- 1. By resolution, Council may temporarily suspend the provisions of this Part 4 requiring coin deposit in parking meters and establishing a maximum parking time limit at meters.
- 2. The Borough shall have authority to establish no-parking or special-purpose parking areas within any parking meter zone, and to remove parking meters or to change the time thereof from these areas if previously installed there, and the provisions of this part shall not apply in those areas where no-parking or special-parking shall be in effect.

Part 5

Pedestrians

§15-501. Pedestrian-control Signal Locations Established.

1. At the locations listed below, pedestrian-control signals shall be erected (or are ratified if previously erected):

At Intersection of	For Pedestrians Crossing	Direction	Days and Hours
Third Street and Insurance Street	Third Street	Northbound and southbound	At all times

- 2. Every pedestrian facing a steady signal exhibiting "Don't Walk" shall not start to cross the roadway in the direction of the signal, but any pedestrian who has partially completed his crossing on the "Walk" signal, shall proceed to a sidewalk or safety zone while the "Don't Walk" signal is showing.
- 3. Whenever the "Don't Walk" indication is flashing, pedestrians shall not start to cross the roadway in the direction of the indication, but any pedestrian who has partly completed crossing during the "Walk" indication shall proceed to a sidewalk or safety zone, and all drivers of vehicles shall yield to the pedestrian.

§15-502. Locations Where Pedestrians Crossing in Unmarked Crosswalks Restricted.

In locations listed below as "pedestrian crossing unlawful" it shall be unlawful for any pedestrian, except where authorized by a police officer or other appropriately attired person with authority to direct, control or regulate traffic, to cross the roadway at that location.

§15-503. Locations Where Pedestrians May Cross Highway Only in Crosswalk.

It shall be unlawful for any pedestrian:

- A. To cross any roadway in a business district within the Borough except in a crosswalk.
- B. In locations listed as "Cross in crosswalk only" in §15-502, to cross the roadway except in a crosswalk.

Any person who violates any provisions of this Part 5 shall, upon conviction, be sentenced to pay a fine of \$5 and costs.

Part 6

Residential Permit Parking

§15-601. Findings.

The Council finds that:

- A. Certain streets in residential areas of the Borough of Beaver are unduly congested by the movement and parking of commuter vehicles (as identified below).
- B. Such congestion is due to the proximity of governmental facilities and commercial establishments which attract a considerable number of commuter vehicles.
- C. Such congestion has had an adverse impact upon the residential character of the affected areas and poses a threat to the health, safety and welfare of residents of those areas.
- D. Such congestion by commuter vehicles substantially inconveniences the local residents, by depriving them of the opportunity to park their own vehicles near their homes.

§15-602. Purposes.

The purposes of this Part are to:

- A. Preserve the character of residential districts of this Borough.
- B. Protect the health and safety of local residents by minimizing vehicular traffic in neighborhoods and thereby reducing danger to children and other pedestrians and preventing air pollution from automotive emissions.
- C. Conserve the value of property in residential districts of this Borough.
- D. Promote the convenience, comfort and general welfare of residents of this Borough.

§15-603. Definitions.

As used in this Part, the following words and phrases shall have the meanings specified:

COMMUTER VEHICLE — a motor vehicle parked in a residential area by a person who is not a resident of the Borough of Beaver.

MOTOR VEHICLE — an automobile, van, truck, jeep, utility vehicle or motorcycle.

RESIDENT — an individual who owns or leases real property in a residential area, or who is a bona fide resident of such area as either a member of a resident's household, or otherwise.

RESIDENTIAL AREA — any area classified as an R-1 (low density residential) District under the Zoning Ordinance [Chapter 27] and official Zoning Map of the Borough of Beaver, or any part thereof designated by the Council.

§15-604. Permit Parking Streets.

1. The following residential area streets are designated for parking by valid permit only:

Commerce Street	Between Turnpike Street and Canal Street	West

Dravo Avenue	Between Turnpike Street and Fourth Street	Both
Fourth Street	Between Commerce Street and Market Street	North
Fourth Street	Between Dravo Avenue and Commerce Street	Both
Turnpike Street	Between Navigation Street and Commerce Street	Both
Market Street	Between Fourth Street and Canal Street	Both

2. Signs shall be erected and maintained along the designated streets to indicate the days and hours when a residential parking permit is required.

§15-605. Permit Required.

The parking of motor vehicles on the streets designated above, between 8:00 a.m. and 4:00 p.m. on Monday through Friday, is limited and restricted to only those vehicles which display a valid residential parking permit.

§15-606. Application for Permit.

- 1. Any person desiring to obtain a residential parking permit shall submit a written application to the Chief of Police on a form prescribed for that purpose. Such application shall set forth the applicant's name, residence address and driver's license number and the make, model and registration plate number of the subject vehicle. Upon request, the applicant shall present for inspection his or her driver's license and the vehicle's registration card.
- 2. The application shall be accompanied by payment of the fee prescribed by the Council to defray the costs to the Borough for administering the permit program.
- 3. A separate application and fee shall be required for each vehicle.
- 4. A local resident may apply for a permit to authorize parking by visitors of such resident. No more than one visitor permit may be issued to any one dwelling unit within the residential area. The application for a visitor permit shall state the reason(s) why the permit is being requested.

§15-607. Issuance of Permit.

- 1. Upon finding that the applicant is entitled to a residential parking permit, the Chief of Police shall issue it. The permit shall show the registration number of the motor vehicle, the name and address of the holder, and the expiration date. All permits shall automatically expire on December 31. Permits shall be renewable annually before the expiration date, upon making the application for renewal and payment of the permit fee.
- 2. Upon finding that the reason(s) presented for a visitor permit establish good cause, the Chief of Police shall issue it. Such a permit may be limited in its duration, according to the circumstances shown.

§15-608. Effect of Permit.

- 1. The holder of a residential parking permit shall be permitted to park a motor vehicle in any designated residential parking area during those times when a parking of motor vehicles is permitted in that area. While a vehicle for which a residential parking permit has been issued is so parked, that permit shall be displayed so as to be clearly visible through the windshield of the vehicle.
- 2. A residential parking permit shall not guarantee or reserve to the holder a parking space within a designated residential permit parking area.
- 3. A residential parking permit shall not authorize its holder to park a motor vehicle in any place where or at any time when stopping, standing or parking of motor vehicles is prohibited or set aside for other specified types of vehicles, nor shall the permit exempt its holder from the observances of any traffic or parking regulation other than those specified in the Part.
- 4. The holder of a permit who ceases to be a resident in a designated parking area shall so notify the Chief of Police and shall surrender his or her parking permit.

§15-609. Revocation of Permit.

The Chief of Police shall have authority to revoke the parking permit of any permit holder found to be in violation of any provision of this Part. Upon written notification to him or her of the revocation, the permit holder shall surrender the permit to the Chief of Police.

§15-610. Prohibited Acts.

- 1. It is unlawful to park a motor vehicle on a street designated in §604 of this Part between the hours of 8:00 a.m. and 4:00 p.m. on Monday through Friday unless a valid residential parking permit is displayed in such vehicle.
- 2. It is unlawful for the holder to transfer a residential parking permit to any other person.
- 3. It is unlawful to display a residential parking permit in a vehicle other than that for which such permit was issued.
- 4. It is unlawful to furnish false information in connection with an application for a residential parking permit.

5. It is unlawful to make or to display a counterfeit residential parking permit.

§15-611. Penalties.

Any person who violates any provision of this Part shall, upon conviction, be sentenced to pay a fine of \$35, together with any costs of prosecution.
