AGREEMENT ON USE OF FACILITIES

(Hereinafter called the sponsor) hereby applies for permission to use a facility of the Borough of Beaver for the purpose of conducting activities thereon.

In consideration of being granted this privilege, the Sponsor hereby agrees with the Borough as follows:

1. The subject premises have been inspected on behalf of the Sponsor and are acceptable for use "as is".
2. THE BOROUGH MAKES NO WARRANTY, EITHER EXPRESS OR IMPLIED, AS TO THE HABITABILITY OR THE SAFE CONDITION OF THE PREMISES.
3. During its usage, the Sponsor will maintain the premises in sanitary condition and good repair, except for ordinary wear. The Sponsor shall not destroy, damage or deface the premises.
4. The Sponsor will comply with the rules and regulations posted by the Borough on the premises.
5. The Sponsor shall be responsible for the conduct of its members and invitees, and shall not permit such persons to do anything upon the premises which the Sponsor may not do.
6. On behalf of each and all of its members and invitees, the Sponsor hereby assumes all risks of property damage and personal injury resulting from use of the subject premises.
7. On behalf of each and all of its members and invitees, the Sponsor hereby renounces and waives any claim against the Borough, and hereby releases and discharges the Borough from liability and all obligations relating to property damage and personal injury resulting from use of the subject premises.
8. The Sponsor will Indemnify and hold harmless the Borough against any liability, loss or expense relating to property damage or personal injury resulting from or occurring during the Sponsor's use of the subject premises,
9. If any provision of this agreement is held by a court of competent jurisdiction to be invalid or unenforceable, the remaining provisions shall nevertheless continue in full force and effect.
10. The undersigned individual hereby represents and warrants that he or she is authorized to execute this agreement on behalf of the Sponsor, and hereby promises to personally indemnify the Borough against any loss or expenses resulting from breach of this warranty.
