## AGREEMENT ON USE OF FACILITIES

- 5. The Sponsor shall be responsible for the conduct of its members and invitees, and shall not permit such persons to do anything upon the premises which the Sponsor may not do.
- 6. On behalf of each and all of its members and invitees, the Sponsor hereby assumes all risks of property damage and personal injury resulting from use of the subject premises.
- 7. On behalf of each and all of its members and invitees, the Sponsor hereby renounces and waives any claim against the Borough, and hereby releases and discharges the Borough from liability and all obligations relating to property damage and personal injury resulting from use of the subject premises.
- 8. The Sponsor will Indemnify and hold harmless the Borough against any liability, loss or expense relating to property damage or personal injury resulting from or occurring during the Sponsor's use of the subject premises,
- 9. If any provision of this agreement is held by a court of competent jurisdiction to be invalid or unenforceable, the remaining provisions shall nevertheless continue in full force and effect.
- 10. The undersigned individual hereby represents and warrants that he or she is authorized to execute this agreement on behalf of the Sponsor, and hereby promises to personally indemnify the Borough against any loss or expenses resulting from breach of this warranty.
