1. The person or group signing for the Park Reservation will be solely responsible for any damages to the Parks/Gazebo and/or its contents and will be assessed above and beyond the reservation fee.
2. You or your group will be responsible for cleaning up the pavilion when you are finished. All trash must be put in the proper receptacles.

Agreement:

The applicant hereby agrees with the Borough as follows:

1. The subject premises have been inspected on behalf of the applicant and are acceptable for us "as is".
2. THE BOROUGH MAKES NO WARRANTY, EITHER EXPRESS OR IMPLIED, AS TO THE HABITABILITY OR THE SAFE CONDITION OF THE PREMISES.
3. During its usage the applicant will maintain the premises in sanitary condition and good repair, except for ordinary wear. The applicant shall not destroy, damage or deface the premises.
4. The applicant will comply with the rules and regulations posted by the Borough on the premises.
