Borough of Beaver, PA Work Session Meeting October 24, 2023 Minutes

- A regular scheduled work session meeting of Beaver Borough Council was held in the Community Room and called to order on Tuesday, October 24, 2023 at 7:00PM by Council President, Alexander Andres.
- Council Representatives in attendance: Alexander Andres, Michael Deelo, Roberta Good, Whitney Learn-Conjeski, Margaret McKean, Jim Perini, Alex Sebastian, Sean Snowden, and Amy Stettler.
- Borough officials in attendance: Mayor Thomas Hamilton, Chief of Police and Borough Manager Dan Madgar, Sergeant Ken McCoy, Finance Manager Andy Kennedy, Code Enforcement Officer Rick Sprecker, and Rebecca Phillips.

Officer Robert Applegarth and Officer Tyler Ursida recognized and welcomed to the Beaver Borough Police Department.

Public Participation –

- Ellen Kretchmar, Ward 2
 - Believes that too much of the budget is allocated to police services and asked that Council take this into consideration when preparing for next year's budget.
 - Mr. Snowden With the guidance of the Finance Manager, Council votes and approves a budget each year based off of not only expenses but revenue brought in to the Borough and how to best keep the community safe. There have been no other complaints from residents that too much of the budget is spent towards police services.
 - o Asked what the overall budget of the renovations to the old pool house is.
 - Ms. Stettler Initially, the project was quoted over \$3 million. The Borough is projecting to keep the project at approximately \$1 million. The approximate \$450,000 of ARP funds will be used towards the \$1 million budget.
 - Asked how Council knew that residents wanted the old pool house to be renovated.
 - Ms. Stettler Council did not want the building to sit empty. The repurposing of the building would benefit the town as an asset and also as potential revenue. Feedback was received by conversations with different members of the community.
 - Mr. Andres Members of Council were voted to serve in their positions by people who trusted them to make decisions on what is best for the town.
 - Mr. Snowden Polls have been done in the past for large projects such as the pool and a very low percentage of residents participated in the survey.
 - Asked to set up a meeting with Mr. Sebastian and if there is a code of conduct policy for social media posts.

Council Committee Reports

Shaw Park / Pool -

• Ms. Stettler complimented the Shaw Park Project's social media presence.

Public Safety / Code Enforcement –

- Ms. McKean asked that the phone located outside of the Borough building be looked at, as it is difficult to hear the person on the other end of the line.
- Ms. McKean addressed concerns of someone walking in the middle of the street who she believes has mental health issues.
 - Mr. Madgar Concerns such as this should be directed to the 911 center.
 - Mr. McCoy Residents will start to see more people from out of town with the new Homeless Shelter located in Vanport. The Police Department has seen an increase in these types of calls. Always call 911 when you see something suspicious.

Highways - Reported by Mr. Deelo

• Paving projects are still on hold until Columbia Gas completes their work. Paving will most likely take place in the Spring of 2024. Patch work and trench repairs will continue this year.

Recreation -

- Ms. McKean asked if Friends of Beaver Parks would be contributing to the renovations to the pool house project.
 - Ms. Stettler The amount to be donated towards the project is subject to how much the ministage at Quay Park costs. Friends of Beaver Parks did state they would earmark funds towards the pool house project.
 - o Ms. McKean No borough funds are to be used towards the mini-stage at Quay Square.
 - Mr. Madgar No borough funds are being used towards the project. The project is being funded by Friends of Beaver Parks. The Borough workers will assist with some digging and miscellaneous work.
 - Ms. Stettler The only plans for Quay Square are for the stage to be installed. There are no plans for the sidewalks at this point.
