Motion by Ms. McKean, I move that Beaver Borough Council censure Council President Alexander Andres for his recent derogatory comments about Kretchmar's Bakery on his personal Facebook page. Such action is inconsistent with Council's obligation to maintain an open public forum without fear of reprisal. Seconded by Mr. Perini. Roll call vote: Mr. Andres – Abstained, Mr. Deelo – No, Ms. Good – No, Ms. Learn-Conjeski – No, Ms. McKean – Yes, Mr. Perini – Yes, Mr. Sebastian – No, Ms. Stettler – No. Roll call vote failed 2-5.

Motion by Mr. Sebastian to adjourn. Seconded by Ms. Stettler. Voice vote passed unanimously.
