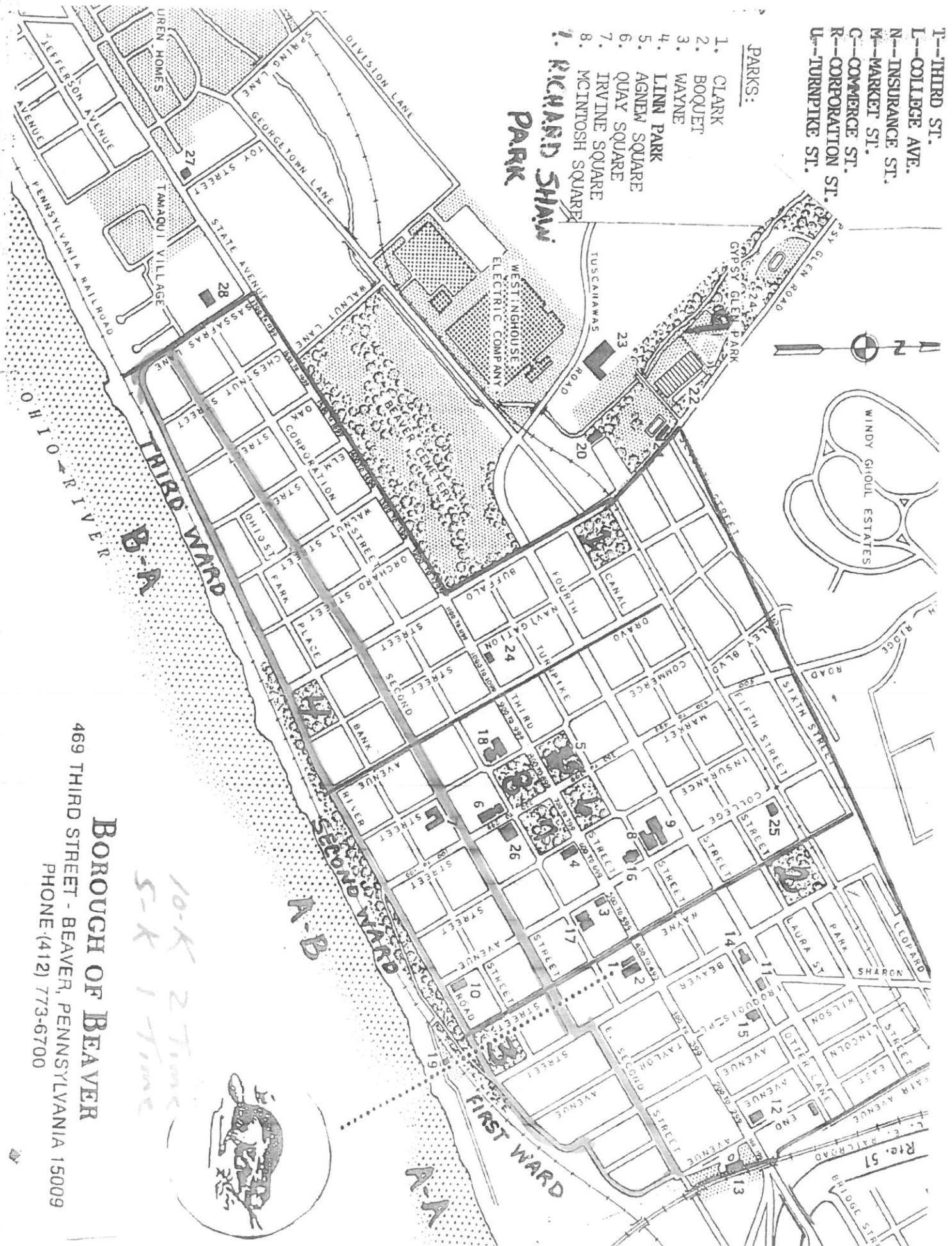
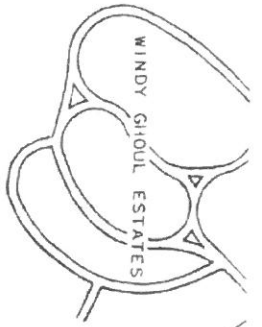
**THIS FORM IS TO BE USED TO APPLY FOR PARADES AND 5K
WALKS/RUNS IN THE BOROUGH OF BEAVER, PA 15009**

1. A copy of the application must be filled out and submitted to the Beaver Chief of Police and the Mayor of Beaver Borough.
2. The Parade Route, Procession Route and Street Closing information must be provided in **DETAIL** in order for the Police Department to locate such information provided on this application.
3. A diagram of the Parada Route showing the location must accompany the application. (The Borough has a pre-determined route for 5k Walks/Runs that will be provided with the application.
4. Applications must be submitted 60 days prior to the date of the event being held.
5. Proof of Liability Insurance ***MUST*** be attached to the application.
6. The Indemnity Agreement must be signed by an authorized representative of the organization requesting the permit.
7. Upon submission of application to The Beaver Police Department, there will be a charge of \$100. Check or Cash is accepted.
8. Upon approval by the Chief of Police and the Mayor of Beaver Borough, the representative of the organization will be notified by the Police Department.
9. Clean up is the responsibility of the Applicant. Failure to abide with this clause may result in denial of future event.
