• Addressed a comment made from the public at the December Council Meeting that referenced "stealing from the Capital Fund." Mr. Fedeles ensured the public and Council that there is no theft or stealing from

Mr. Fedeles clarified that money in the Capital account is not strictly allocated to the Capital account, it can be moved to different line items in the General Fund Budget.
