- A regular scheduled work session meeting of Beaver Borough Council was held in the Community Room and called to order on Tuesday, February 25, 2025 at 7:00PM by Council President, Sean Snowden.

Public Participation –

- Ellen Kretchmar, Ward 2
 - Quoted the Pennsylvania Sunshine Act.
 - o Believes that the current Borough practices cause her to file Right to Know requests.
 - Witnessed a disorderly conduct incident on Third Street.
 - Believes that the Police Department should track how many non-medical emergencies are responded to, at what time of day, and what type of incident it is.
 - o Believes that there are violations of the Ethics Act by Council members and plans to take action.

Finance – Reported by Ms. Stettler and Mr. Hindman

- Presented a draft summary report of the budget that lists notable budget expenses.
- Pool house revenue and rentals can be provided on a quarterly basis.
- A draft 5-year plan to be presented at the Work Session.

Highways – Reported by Mr. Deelo

- Reviewed meeting with Columbia Gas. Currently, small projects are planned for 2025 and 2026.
- Mr. Madgar explained that the Borough benefitted from Columbia Gas work. Columbia Gas contributed to
 most of the paving that was completed. The Borough will not be able to complete as much paving without
 their projects and therefore their contributions. A list of roads is being created by the Engineer to prioritize
 paving.

Reports

Manager/Secretary Report - Reported by Mr. Madgar

- At the March Council Meeting, a motion will be presented to approve the quote for the upgrade of the Police camera server system. This quote is in the amount of \$19,400. This work is expected to begin in April or May. These funds are being reallocated from the Police vehicle line item.
- Reviewed life insurance option for the Fire Department members. The Borough can see a reduce in the cost of the policy by adding members of the Fire Department.
 - o Ms. McKean asked if we can reach out to cooperating fire departments and have them be added to the policy, then there could be more savings with a broader number.
 - Mr. Madgar stated that due to workers compensation, etc., this would be best for COG to look into.
- Yard Waste Permits can now be renewed online.
- Reviewed Senior Scams event/speaker series with Detective Jim Degori and the District Attorney's office at the Pool House. Mr. Madgar thanked Pam Learn for coordinating.
- In April or May, carpet will be installed at the Pool House to help address the echo. The noise will be reassessed after the carpet is installed.
- To date in 2025, approximately \$20,000 has been spent on salt for the roads due to the harsh weather. Approximately \$6,000 has been spent in overtime due to plowing.
- Recent repair to a plow truck was approximately \$3,500.
- Office printer needed repaired costing approximately \$600.
- Heater repairs at the Fire Department costing approximately \$4,000.
- Reviewed continuous Right to Know request costs:
 - o Estimated that the requests have costed the Borough approximately \$20,000 this year.
 - o 1,669 pages have been provided to one requestor through Right to Know requests.
 - Ms. McKean suggested consulting with other Boroughs on how they have responded to right to know requests before consulting the Solicitor.
 - Mr. Madgar addressed concerns about the amount of employee time that is being spent on the requests.

Mayor Hamilton –

- Reviewed Senior Scam Speaker Series at the Pool House and the partnership with the Beaver Area School District to organize.
- Reviewed Beaver County's new DNA technology to process DNA faster. This will cut down on local communities that need this type of service for serious crimes.

Police Chief Madgar – No report

Engineer – No report

President -

- Mr. Snowden addressed the public and explained:
 - The Borough Solicitor is to serve the majority of Council. The Borough has been paying the Solicitor substantially over and above normal amounts as a direct result of right to know requests.
 - o It appears that the same member of the public is targeting specific members of Council.

- The same individual of the public repeatedly brings up issues that have long since been resolved.
- To the extent that it is claimed there to be a violation of the Ethics Act, members of Council
 have and will continue to abstain from votes that have a direct financial impact on family
 members as required under the Ethics Act. This is guided by the Borough's Solicitor.
