- A regular scheduled work session meeting of Beaver Borough Council was held in the Community Room and called to order on Tuesday, July 22, 2025 at 7:00PM by Council Vice President, Amy Stettler.

Zoning Hearing Board –

- The Zoning Hearing Board will meet again on July 30, 2025 at 7PM to review a variance request to allow residential developments at the vacant lot at Corporation Street and Sassafras Lane.

Planning Commission –

- Ms. McKean reviewed the most recent Planning Commission meeting which reviewed their recommendations to update the current signage ordinance.
 - The Borough Solicitor will review the proposed recommendations before the final draft is presented to Council.

Municipal Authority – Reported by Mr. Deelo

- Reviewed upcoming lead regulations for water and sewer authorities.
 - New laws will require the removal of all lead in water system which will require much planning and time to complete.
 - The Municipal Authority's ownership ends at the service line to the resident's home. Many of these service lines are lead. Lead lines must be replaced with non-lead lines within the next 10 years.
 - More regulation information from the EPA and DEP is expected.
 - Additional communication from the Municipal Authority to residents is expected by the end of the year.

Pool Committee – Reported by Mr. Andres

- Members of the Pool Committee and the JROTC will be distributing door hangers this weekend to provide information about the fundraising efforts and events.

Council Committee Reports**Finance –**

- Mr. Hindman - Q2 Review
 - The General Fund is performing well compared to June 2024.
 - Property taxes are about \$100,000 under budget for the first six months due to appeals
 - Police expenses are trending better due to part-time costs being down as a result of hiring a full-time officer.
- Ms. Stettler reviewed that a copy of the 5-year projected budget has been provided to Council and should not be cited as a firm budget or recommendation.
 - The potential need for a new ladder fire truck was reviewed.
- The 2026 preliminary budget is expected to be presented at the August Work Session meeting.

General Government – Reported by Ms. Good

- Attended the last Planning Commission meeting regarding their recommendations to update the current signage ordinance.
 - HARB has been involved with the Planning Commission's review.
- Ms. McKean discussed a hometown heroes program.
 - General concerns about the labor that would need to complete the project, utility pole agreements, obtaining permits, and maintenance concerns were reviewed.
 - Alternative, more unique ideas were reviewed to pay tribute to veterans.
 - Additional discussion of ideas to continue at the next Council Meeting.
- America 250 events reviewed.

- Paving bid is currently being advertised.
 - Bid opening will be held on August 7, 2025.
 - Motion to award the paving bid is expected at the August Council Meeting.

 - The proposed contract will be discussed at the next School Board meeting in August.
- Clock Tower
 - Working to find a vendor to look at the clock tower so it can be controlled from the Borough building.
 - Reviewed considering adding wireless outdoor speakers in the Business District.
- Reviewed a letter from a new resident who spoke very highly of Beaver Borough.
