General Government -

- Mr. Andres received complaints about fireworks in the community, with some people setting them off at late hours.
 - o State laws regarding fireworks were reviewed.
 - Suggested posting the Borough's ordinance for fireworks on the website to inform residents of regulations.

Highways -

- 2025 Road Paving Project bid opening is expected in August.
- Paving project is estimated to start sometime in September.

Public Safety / Code Enforcement -

- Ms. McKean suggested applying for an upcoming PennDOT Transportation Alternatives Set-Aside program grant.
- Mr. Hindman suggested that, in light of the recent tragic events in Texas, it may be worthwhile for the Borough to review its emergency alert systems.
 - Mr. Fedeles explained that emergency action plans exist at both the county and Borough levels and Beaver County Emergency Services conducts annual disaster drills with school districts and local officials. The County also has the ability to send notifications for various warnings to phones.
 - Mr. Snowden stated that the county practices emergency drills once a year and there is a
 positive relationship with the Beaver County Emergency Services on collaborating on safety
 plans.

 will be used to support planning for the 2026 Budget and the 5-Year Plan. Further updates will be provided
